Once approved by the Events Office, a final copy diagram shall be emailed to the Events Office NO LATER THAN 60 days prior to your air show. (A copy is no longer required to be mailed in.)

- e. Friends & Family seating
- f. Friends & Family parking
- g. Communications Cart location with correct coordinate depicted
- h. Narration Stand location
